^On September 30, 2024, there was a significant spike in the price of Kasikornbank PCL ("KBank") due to a trade at the market's close which was seemingly incorrectly routed to Thailand's foreign board. The stock's price returned to its previous levels upon the next executed price within the following two days. On September 30, 2024, Kopernik applied a reasonable fair value to this holding in the portfolio. There was no impact on the Fund's returns. As of September 30, 2024, KBank was neither a significant contributor nor detractor to portfolio contribution and had a minimal impact on total return. As a result, we have removed KBank from the contribution report since the spike in the security's price overstated its effect on the contribution of its sector and region.

Options comprised a Portfolio Average Weight in the fund of 0.67% for Q3 2024 with an estimated contribution of -0.77%. Portfolio Average Weight in the fund was 0.68% for YTD 2024 with an estimated contribution of -3.86%
