
#### ALLOCATION BY REGION\*^

#### DECEMBER 2024



The MSCI All Country World Index is a broad-based securities market index that captures over 2000 primarily large- and mid-cap companies across 23 developed and 24 emerging market countries. #### **GLOSSARY**

Active Share is a measure of the percentage of holdings in a portfolio that differ from the benchmark index. Weighted Average Market Capitalization is the portfolio-weighted mean average capitalizations of all equity securities. Median Market Capitalization is midpoint of market capitalization based on the equity market capitalization of all securities. Trailing P/E is the weighted average ratio of closing price to trailing 12-month market convention earnings per share as of the date of analysis. Trailing P/E is the weighted average ratio of closing price to trailing 12-month market convention earnings per share as of the date of analysis. Trailing EV/S is the weighted average ratio of the enterprise value to trailing 12-month sales as of the date of analysis. Small-Cap = less than \$2 billion. Mid-Cap = \$2 billion . Large-Cap = greater than \$10 billion.
